Polyglass® U.S.A., Inc. warrants that Polybrite® Silicone Coatings (Polybrite® PB90, Polybrite® PB95 Polybrite® PB 90.1 and Polybrite® PB 95.1) will comply with published physical properties at the time of manufacture. Also, the product shall be free of defects for a term of 50 years. Refer to warranty document for exact terms and conditions. Warranty document may be obtained by emailing warranty@polyglass.com. The substrate/surface to which the Polybrite® Silicone is applied shall comply with all application instructions, recommended procedures and maintenance requirements. Substrate to be structurally sound with a reasonable life expectancy prior to application of Polybrite® Silicone Coating.

Polyglass is a manufacturer of roofing and coating materials and has no control over the variables involved during the application of Polybrite® Silicone Coating, therefore cannot guarantee results of the application including, but not limited to:

- Appearance, watertight capabilities, and suitability of the substrate.

Warranty specifically excludes all costs and damages resulting from the presence of any the product's components, substrate related factors, hazardous materials, or environment/location in which the Polybrite® Silicone Coating is installed or applied. Warranty excludes abuse of installed Polybrite® Silicone Coating in any way, including but not limited to; pedestrian traffic, physical abuse, substrate failure, animal life, Vandalism, Acts of God and any natural disaster.

Warranty will be void or may be subject to specific limitations if the Polybrite® Silicone Coating is painted, repaired or covered in any product other than Polybrite® Silicone Coating. This warranty is limited to the Polybrite® Silicone Coating only and makes no provisions for cleaners, primers or other secondary materials. If Polybrite® Silicone Coating fails to comply with its warranty related conditions Polyglass will replace the defective Polybrite® Silicone Coating at no cost to the purchaser.

Polyglass' sole liability is limited to replacement of any Polybrite® Silicone Coating shown to be defective as warranted within a 50 year period from the date of purchase, subject to all warranty conditions. The system as installed must comply with published application specification/requirements available from Polyglass. Warranty does not extend to labor costs for any type of site observation, testing or repair of the Polybrite® Silicone Coating system or any other labor costs. Any notice of claimed defect in materials shall be sent in writing to Polyglass per the Claims Procedure on the warranty document. The warranty is in effect only for product purchased from a distributor authorized by Polyglass to sell its product. The warranty will be null and void if the Polyglass distributor has not received payment in full for the products related to the manufacturer's warranty.

POLYGLASS OFFERS NO OTHER WARRANTIES, EXPRESSED OR IMPLIED. WARRANTY SPECIFICALLY EXCLUDES ALL LABOR, COSTS OF LABOR, AND ALL INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND.
